STATEMENT BY MALAYSIA

57TH SESSION OF THE JOINT ADVISORY GROUP (JAG) OF THE INTERNATIONAL TRADE CENTRE (ITC) THURSDAY, 20 JULY 2023, 3 PM., ROOM S1, WTO

Thank you Chair for giving me the floor. Please allow me to deliver Malaysia's statement on behalf of Ambassador Syahril Ghazali, who has to attend another important meeting at the same time today.

- 1. Firstly, we would like to express our gratitude on the opportunity to join the ITC's 57th Joint Advisory Group Meeting and we would like to congratulate ITC for another productive year in 2022.
- 2. Malaysia recognises the ITC and European Union as our important partners, hence we applaud the EU's continued commitment through ARISE Plus Malaysia trade-related technical assistance (TRTA), particularly in the aspects of trade policies formulation, quality infrastructure system and sustainable agriculture practices. As a key partner in implementing the projects, I must underscore our appreciation to the ITC team for their full cooperation rendered to the Ministry of Investment, Trade and Industry (MITI) and other domestic stakeholders.
- 3. On this note, I wish to highlight that the on-going ARISE Plus Malaysia project, which spans from the period between 1 February 2021 to 31 January 2024, are now entering the final phase. It is important to note that the project conducted, has helped Malaysia to:

- i.) increase and enhance our respective officials' competitiveness, particularly in formulating robust trade and investment policies;
- ii.) improve and assist Malaysia in developing a high-quality infrastructure system that will contribute to the country's sustainable development and effective participation in international trade; and
- iii.) strengthen national and regional agricultural supply chains by promoting sustainable and internationally quality-compliant practices in the agri-food and fisheries sectors.

In our assessment, the project journey had not been easy especially during the first half of the project phase, with much of the trainings and programmes were conducted virtually due to the pandemic restrictions. Great synergies continue to reap in the second half of the project as more in person events and trainings were conducted in the year of 2022 onwards.

Furthermore, from our observation, the targeted and specific workshops related to policy formulation to align with international commitments such as exposure to the most recent trends in Free Trade Agreements (FTAs), investment treaties, improvement to the rules of origin mechanism, e-commerce regulatory framework, standards certification or mutual recognition, as well as promoting sustainable agricultural industry, have been complementary to the on-going economic integration efforts by Malaysia.
